Dear Sir.

- 1. I, Kanwaljit Singh, Practicing Company Secretary, at S.C.O. 64-65, 1<sup>st</sup> Floor, Sector 17 A, Madhya Marg, Chandigarh was appointed as Scrutinizer by the Board of Directors of Paul Merchants Limited (the Company) for the purpose of scrutinizing the e-voting process (remote e-voting) and voting by postal ballot pursuant to section 110 of the Companies Act, 2013 read with rule 22 of the Companies (Management and Administration) Rules, 2014, as amended, in respect of the below mentioned resolution.
- 2. The compliance with the provisions of the Companies Act, 2013 and the Rules made there under relating to voting through electronic means (by remote e-voting) and voting by postal ballot by the shareholders on the resolution proposed is the responsibility of the Management. My responsibility as a Scrutinizer is to ensure that the voting process both through electronic means and by postal ballot are conducted in a fair and transparent manner and render a consolidated scrutinizer's report of the total votes cast in favour or against, if any, to the Chairman or any other person authorized, on the resolution, based on the reports generated from the electronic voting system provided by Central Depository Services Limited (CDSL) and the report for voting by postal ballot.
- 3. The Company had arranged the services of CDSL for extending the facility of remote evoting to the Members of the Company from 3<sup>rd</sup> October, 2017 (from 9.00 A.M.) to 1<sup>st</sup> November, 2017 (upto 5.00 P.M.). The remote e-voting results were unblocked by me bn 2<sup>nd</sup> November, 2017 in the presence of two witnesses.

- 4. The company has completed on 27<sup>th</sup> September, 2017, the dispatch of postal ballot forms along with postage prepaid business reply envelope to its members whose name (s) appeared on the register of members/ list of beneficiaries as on 22<sup>nd</sup> September, 2017. All postal ballot forms received up to the close of working hours on 1<sup>st</sup> November, 2017, the last date fixed by the Company for receipt of the forms, were considered for my scrutiny. Envelopes containing postal ballot forms received after 1<sup>st</sup> November, 2017 were not considered for my scrutiny.
- 5. I have rendered Scrutinizer's Report separately on the remote e-voting and on Postal Ballot and I hereby submit Consolidated Report of Scrutinizer.
