



डॉक्टर ने लगाया आरोप, अस्पताल की लापरवाही सामने लाने की मिली सजा

प्रतिभा शुक्ल नई दिल्ली, 2 सितंबर

अस्पतालों में बढती हिंसा की एक घटना बीते दिनों दिल्ली के सेंट स्टीफंस अस्पताल में दिखी, जहां अस्पताल में ही एक डॉक्टर की हत्या कर दी गई थी। कमोबेश ऐसे ही हालात जाने-माने राम मनोहर लोहिया अस्पताल में भी हैं। यहां के एक जूनियर डॉक्टर ने पुलिस को दी अपनी शिकायत में दावा किया है कि कुछ लोगों ने उन्हें मारने की धमकी दी है। पुलिस व अस्पताल प्रशासन को दी गई शिकायत में जूनियर रेजिडेंट डॉ गुलाब सिंह सोलंकी ने आरोप लगाया है कि वरिष्ठ डॉक्टर व सहायक डॉक्टर उनका मानसिक उत्पीड़न कर रहे हैं। सोलंकी के मृताबिक, अस्पताल में मरीजों की अनदेखी किए जाने और दसरे डॉक्टरों के ड्यूटी से गायब रहने का विरोध करने पर उन्हें निशाना बनाया जा रहा है।

सोलंकी का यह भी आरोप है कि कुछ अज्ञात लोगों ने उन्हें मारने की धमकी भी दी है। उनका कहना है कि कई महीने पहले की गई उनकी शिकायत पर अभी तक कोई कार्रवाई नहीं की गई थी, लेकिन जैसे ही इस बारे में मीडिया ने पृछताछ की वैसे ही एक जांच समिति बना कर जांच शुरू कर दी गई। कुछ दिन पहले सेंट स्टीफंस अस्पताल में डॉ शाश्वत पांडेय की हत्या कर दी गई थी। उनके परिजनों का

कहना था कि अगर डॉ पांडेय की शिकायत को गंभीरता से लिया गया होता तो शायद वे आज जिंदा होते। दिल्ली के दसरे अस्पतालों में भी स्थित ऐसी ही है, जहां किसी न किसी वजह से डॉक्टर अपने ही सहयोगियों की हिंसा का शिकार हैं। आरएमएल के डॉ सोलंकी का कहना है कि उनको मरीजों के साथ लापरवाही बरतने के खिलाफ आवाज उठाने के चलते निशाना बनाया जा रहा है। उन्हें अपने साथियों के हाथों प्रताडित होकर मानसिक तनाव व अवसाद भी झेलना पड रहा है। अस्पताल के इमरजंसी वार्ड में जनियर रेजिडेंट रहे डॉ सोलंकी ने 17 अगस्त को इस बाबत नार्थ एवेन्यू थाने में शिकायत दर्ज कराई थी। अस्पताल प्रशासन को भी उन्होंने लिखित शिकायत दी थी. लेकिन अभी तक न तो पुलिस और न ही अस्पताल प्रशासन की ओर से कोई जांच की गई।

डॉ सोलंकी का कहना है कि वे इमरजंसी में डेढ साल से काम कर रहे थे। उनका आरोप है पहले उनको नौकरी

छोड़ने की हिदायत दी गई और ऐसा न करने पर एक महिला डॉक्टर ने उन्हें किसी मामले में घसीटने की धमकी भी दी। आरोप है कि शिकायत दर्ज करवाने के बाद 21 अगस्त की रात दो जब वे ड्यूटी पर जा रहे थे तो कुछ अनजान लोगों ने उनसे शिकायत वापस लेने की बात कही और फिर जान से मारने की धमकी दी।

अस्पताल के इमरजंसी वार्ड में रात के समय पांच-छह डॉक्टरों की ड्यूटी लगाई जाती थी, लेकिन इनमें से कई डॉक्टर ड्यूटी के दौरान गैर-हाजिर रहते थे। इसके कारण ड्यटी पर मौजद एक-दो डॉक्टरों पर जरूरत से अधिक दबाव तो रहता ही था, साथ ही मरीजों की देखभाल भी प्रभावित होती थी। इसकी शिकायत उन्होंने मौखिक तौर पर विभाग के वरिष्ठ डॉक्टरों से की, लेकिन ऐसे डॉक्टरों के खिलाफ कार्रवाई के बजाय उन्हें ही परेशान किया जाने लगा। आरोप है कि सीएमओ सहित अन्य डॉक्टरों ने गृटबंदी करके सोलंकी खिलाफ शिकायत दर्ज करा दी। इस शिकायत में डॉ सोलंकी के काम और आचरण पर असंतोष जताया गया और कहा गया कि इमरजंसी वार्ड के हिसाब से उनका काम संतोषजनक नहीं है, इसलिए उन्हें किसी दुसरी जगह भेज दिया जाए। इस बारे में अस्पताल प्रशासन के एक वरिष्ठ अधिकारी ने कहा कि डॉ सोलंकी के खिलाफ जांच चल रही है। उनका व्यवहार सहयोगियों व मरीजों के प्रति ठीक नहीं है।

गाजीपुर कचरा पट्टी में शुक्रवार को हुए हादसे के बाद दिल्ली में कचरे की व्यवस्था पर कई सवालिया निशान लगे हैं। बड़े स्तर साल कितना कचरा प्राप्त होता है? कचरे की तो बात छोड़ें, हालात इतने खराब हैं कि इसके लिए काम करने वाली एजंसियों को यही नहीं मालूम है कि दिल्ली के बस स्टॉपों पर कितने कूड़ेदान हैं। सूचना अधिकार कानून (आरटीआइ) के तहत मांगी गई जानकारी के तहत तीनों निगम इस जानकारी को बताने में नाकाम रहे।

के निपटान के लिए बस स्टॉप लगाए गए कडेदानों के लिए डेम्स (पर्यावरण प्रबंधन सेवा विभाग) को कितना बजट मिलता है ? इन सभी सवालों के तीनों निगमों से लगभग एक जैसे ही जवाब मिले लेकिन दुर्भाग्य से इनमें से किसी सवाल का जवाब निगम के डेम्स की ओर से नहीं मिला। 2016 में दिल्ली के तीनों नगर निगमों उत्तरी और दक्षिणी दिल्ली नगर निगम की ओर से जवाब में कहा गया कि डेम्स की ओर से बस स्टॉप पर कोई कूड़ेदान की व्यवस्था नहीं कि गई है। इसके अलावा जवाब में बताया गया कि 2014-15 और

कुड़ेदान लगा रहे हैं। आरटीआइ के तहत दिल्ली परिवहन निगम ने जानकारी दी कि दिल्ली में 4.987 बस स्टॉप हैं। इन 4.987 बस स्टॉप में से कितनों पर कितने कडेदानों की व्यवस्था है. यह जानकारी निगम के पास नहीं है। पूर्वी दिल्ली नगर निगम के जनसंपर्क अधिकारी योगेंद्र मान का कहना है कि दिल्ली में कचरा निस्तारण हेत जगह तो है पर निगम के अधिकार क्षेत्र में नहीं है।

किसी व्यक्ति को गहरे सीवर, सैप्टिक टैंक, नाले, सीवर लाईन आदि की सफाई के लिए लगाना गैर कानूनी और दण्डनीय अपराध है। ऐसी स्थिति में व्यक्ति की मृत्यु होने पर भेजने वाले पर गैर इरादतन हत्या का मुकद्मा दर्ज किया जाएगा।



सीवर में कार्य करने के दौरान यदि किसी व्यक्ति की मृत्यु अथवा दुर्घटना होती है तो बिल्डिंग का मालिक, ठेकेदार और संबंधित एजेंन्सी (दिल्ली जल बोर्ड, दिल्ली नगर निगम, नई दिल्ली नगर पालिका, केन्द्रीय लोक निर्माण विभाग, लोक निर्माण विभाग आदि) सामूहिक रूप से जिम्मेदार होंगे और उनपर कानूनी कार्यवाई भी की जाएगी।



आपातकालीन स्थिति में यदि सीवर लाईन में कार्य करना आवश्यक है तो इसके लिए संबंधित सरकारी एजेन्सी से लिखित स्वीकृति के साथ सुरक्षा उपकरणों तथा सभी नियमों एवं सावधानियों का पालन करना जरूरी है।
