This has reference to our earlier disclosure dated 12.12.2022 under Regulation 30 of the SEBI (Listing Obligation and disclosure Listing Requirements) 2015, Regulations, hereinafter referred as ("Listing regulations"), we hereby inform you that Office of the Special Director (Appeals)-FEMA, Room no. 254, 2nd floor, E-2, ARA Centre, Jhandewalan Extension, New Delhi, Government of India vide its Order No. SD (A) / FEM A/ 42/ 2022- 23 / dated 28.07.2023 received by us today i.e. August 05, 2023, has rejected the appeal filed by the Company, against the imposition of Penalty of Rs. 24,00,000/- (Rupees Twenty Four Lakhs Only) on the Company by the Assistant Director, Directorate of Enforcement, Ministry of Finance, Government of India for alleged contravention of provisions of Foreign Exchange Management Act (FEMA), 1999.

Further, the information pursuant to Regulation 30 of Listing Regulations read over with SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015, Circular no. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 and para 8.2 of Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, to the extent applicable to the matter, is as follows:
